Contest Rules

Entry Rules

1. CONTEST PERIOD

2. ELIGIBILITY

This Contest is open to all individuals who: a. Age 15 or older. If entrant is under 15 years of age, there must be a parent or legal guardian present when entering Contest.

3. METHODS OF ENTRY

To cast a vote for your favorite player of the week, you must fill out the entry form online at www.JournalScene.com/POTW each week. There is no purchase required in order to enter the Contest. There is a limit of **ONE (1) entry per person per week and ONE (1) vote per person per week.**

4. PRIZES

5. DRAWINGS
